**A RESOLUTION SETTING AMENDING THE SCHEDULE OF FEES FOR ZONING MATTERS, BUILDING PERMITS AND OTHER SERVICES OR PERMITS IN BRIGHTON TOWNSHIP.**

**WHEREAS**, the Board of Supervisors of Brighton Township previously set forth a schedule of fees in one comprehensive document; and

**WHEREAS**, effective October 1, 2020 the U.S. Department of Housing and Urban Development Office of Manufactured Housing Program requirements have replaced the PA Department of Community and Economic Development requirements for all new manufactured housing installations in PA, requiring additional inspections before such units can be occupied; and the establishment of additional fees for these inspections is warranted.

**NOW, THEREFORE, BE IT RESOLVED**, by the Board of Supervisors of Brighton Township that the fee schedule adopted by Resolution No. 2020-09 is hereby amended as follows:






